<u>Justice Department Announces Plan to Administer Grant Funding Opportunities for Fiscal Year</u> <u>2024 to Strengthen Community Safety</u>

The Justice Department announced its annual plan for making anticipated grant funding available this fiscal year to advance public safety activities and improve justice system outcomes. The Department is inviting community-based organizations; state, local, Tribal, and territorial government agencies, including law enforcement agencies; research institutions; and nonprofit entities to apply for funding from more than 200 grant programs, administered by its Office of Community Oriented Policing Services (COPS Office), Office of Justice Programs (OJP), and Office on Violence Against Women (OVW). As in prior years, the awards will be made later this year, subject to appropriations, and will build on almost \$5.8 billion in grants awarded in Fiscal Year (FY) 2023.

City's Housing and Urban Development Competitive Grant Applications Being Accepted

Louisville Metro Government (LMG) has begun accepting applications from local non-profit organizations for programs or activities seeking funding as sub-recipients to the U.S. Department of Housing and Urban Development grants listed below for LMG fiscal year 2025 (July 1, 2024 – June 30, 2025).

HUD-Funded Grants:

- 1. Community Development Block Grant (CDBG),
- 2. Emergency Solutions Grant (ESG), and
- 3. Housing Opportunities for Persons with AIDS (HOPWA).

These grants are administered locally by the Louisville Metro Office of Resilience and Community Services (RCS). Grant activities are guided by a 5-year Consolidated Plan as well as an annual Action Plan, both of which are available online <u>here</u>.

Institute of Museum and Library Services: USCIS Citizenship and Integration Grant Program Engagement

U.S. Citizenship and Immigration Services (USCIS) invites museum and library employees to participate in a webinar on **Thursday, March 21**, from **2 to 3 p.m. Eastern**, to engage in dialogue about the <u>Citizenship and Integration Grant Program</u>.

Since 2009, USCIS has awarded nearly \$155 million through 644 competitive grants to immigrant-serving organizations, including public libraries. These grants have been awarded in 41 states and the District of Columbia to organizations that provide citizenship instruction, naturalization preparation, or ongoing integration services to immigrants who are eligible to naturalize.

During the webinar, USCIS representatives will:

- Provide an overview of the Citizenship and Integration Grant Program;
- Highlight past grant recipients and the types of organizations that may apply;
- Seek feedback on how USCIS can partner with museums and libraries to promote this information within their networks and local communities; and
- Answer questions.
